

Business Services Contract

This agreement dated this ____ day of _____, 2008, is made by and between _____ who will be referred to as "Client", and **Todd A. Ruggeri (CheckMyWebsite.com)** who will be referred to as "Website Designer" throughout this business services contract.

1. Website Design Services: The Client hereby contracts the Website Designer to perform the following services in accordance with the terms and conditions set forth in this agreement: The Website Designer will consult with _____ concerning matters relating to the design of their pending business website (www._____.com), including the colors to be used, website page content, and general matters arising out of the design of the Client's website. It is anticipated the Website Designer will spend approximately thirty (30) hours in fulfilling his obligations under this contract.

2. Terms of Agreement: This agreement will begin _____, 2008 and will end thirty (30) days from this start date or upon completion of one (1) website design provided to the Client by the Website Designer by uploading the website and its related files to an Internet hosting server provided by the Client. Either party may cancel this agreement with ten (10) days notice to the other party in writing by certified mail or facsimile. The Website Designer will be paid a minimum of \$_____ in accordance with this agreement. The Website Designer will submit an itemized statement, or invoice setting forth the time spent and services rendered, and the Client will pay the Website Designer the amounts due as indicated by statements or invoices submitted by the Website Designer within ten (10) days of receipt of such itemized statement or invoice. Furthermore, the Client will pay 50% of the minimum amount due before any services begin in accordance with this agreement. If the Website Designer has begun any work on the Client's website and the Client makes or requests significant changes to the design of the website, cancels this agreement, or fails to provide all content necessary for the completion of the website within fifteen (15) days from the start of this agreement, the Client forfeits all monies already paid to the Website Designer.

3. Delivery of Finished Website: The Website Designer will complete the website design and post it for viewing on an Internet hosting server provided by the Website Designer for final approval by the Client. Upon receipt of the final portion of the payment for services as outlined in this agreement, the Website Designer will either provide the Client with a compact disc (CD) with the entire necessary website files contained therein, or post the website files to an Internet hosting server provided by the Client.

4. Payment to Website Designer: The Website Designer will be paid at the rate of \$50.00 per hour with a one (1) hour minimum charge for any work performed outside of the scope of this agreement or beyond the completion of this agreement, including, but not limited to any future changes, updates, additions, or deletions to the Client's website.

5. Confidential Information: The Website Designer agrees that any information received by the Website Designer during any furtherance of the Website Designer's obligations in accordance with this contract, which concerns the personal, financial or other affairs of the Client will be treated by the Website Designer in full confidence and will not be revealed or released to any other persons, firms or organizations.

6. Independent Contractor: Both the Client and the Website Designer agree that the Website Designer will act as an independent contractor in the performance of his duties under this contract.

7. Creative Control: The Client will permit the Website Designer full creative control over the design of the website layout, style, font, and page transition. However, the Client will provide acceptable color schemes and all page text content to the Website Designer before rendering of such creative control begins to assist in providing the Website Designer with a design suitable to the needs of the Client. If the Client does not permit the Website Designer to have full creative control over the design of the website, the Client will provide the Website Designer with a website template to use as a guide and all of its related files (e.g. .psd, .fla, images, fonts, HTML, css, .php, and .asp) within ten (10) days of the start of this agreement.
